

This is a great opportunity for students to compete against other students to test their ICT/networking skills and gain recognition with potential employers.

This year, we are offering **3 levels of competitions** (CCNA, CCENT and IT Essentials) for the United States and Canada.

- The competitions will be offered in English and French, but students may only compete in one language.
- Students may only compete in one level each



Bill to Change Indiana Education Board Chair Power

Although Gov. Mike Pence praised the work state officials were doing with Superintendent of **Public Instruction** Glenda Ritz to shorten the ISTEP exam, it didn't deter the Senate from passing a bill that would remove her as the de facto chair of the State Board of Education.

Strong majorities of both houses of the Indiana legislature are signaling they want to clear the way for someone other than state Superintendent Glenda Ritz to lead the Indiana State Board of Education.

Students will need an enrollment key to register. Here are the 2015 keys:

Competition	KEY	Who should enroll?	Competition content
CCNA	USCAN_2015_CCNA	Currently enrolled in or completed in last 10 months the 3 rd or 4 th CCNA course	Geared toward CCNA certifications with a few IoE and soft skills questions per round
CCENT	USCAN_2015_CCENT	Currently enrolled in or completed in last 10 months the 1 st or 2 nd CCNA course	Geared toward CCENT certification with a few loE and soft skills questions per round
IT Essentials	USCAN_2015_ITE	Currently enrolled in or completed in last 10 months the IT Essentials course	Geared toward IT Essentials course content with a few IoE and soft skills questions per round

Instructors may use the same keys to enroll in one, two or all three competition levels. Within 72 hours of enrolling, instructors will be moved into an Instructor-Observer role, which allows them to view the list of students enrolled where they can sort by state/province or academy.

There will also be a **Practice Site** open during Registration and the entire competition period.

passed the Senate 33-17 today. The Indiana House passed a similar bill this past week, House Bill 1609, 58-40.

The bills have different specifics, but both would let the state board elect its own leader from among its members. It's all but certain that the board, entirely appointed by Republican governors, would choose someone other than Ritz.

Senate Bill 1, would allow the Board of Education to choose its own chair and would trim the board from 11 members to nine. It is sponsored by Sens. Travis Holdman and Brandt Hershman.

The bill also would shift power away from the governor, who now appoints all members except the superintendent of public instruction, and would allow
